New encryption device that will replace smart cards, the USB Key, unifies the functionalities of a smart card and a card reader. In addition to the PKI functionality – certificate and electronic signature – the bank's clients will also receive a standard 1 GB USB flash disk, which enables the Bank to store special software packages, and the users can save their own documents with encryption protection – "4 in 1" device.

The introduction of the USB Key will influence significantly the Client Satisfaction Index (CSI): it enhances mobility – no need for a card reader, only a standard USB interface required, it is extremely convenient for those clients who use the service on laptops, it is ergonomic and small and it can be easily used on any computer.



Complex Projects in Romania

ROMANIA: In Q1 2009, Asseco SEE (Net Consulting) delivered Token Vasco Digipass products and HP equipment and installation services for two major Romanian banks.
